VIETNAM VETERAN BENEFITS

We did it! Working together, advocates for veterans, Parkinson's and LBD called on Congress to support the Fair Care for Vietnam Veterans Act. As a result, Vietnam veterans who developed parkinsonism because of their service now qualify for VA benefits!

And LBDA applauds Congress's bipartisan effort to take it over the finish line. Despite the veto from President Trump, Congress passed the National Defense Authorization Act (NDAA) for fiscal year 2021 with a veto-proof majority on January 1st. The Fair Care for Vietnam Veterans Act was included in the NDAA, which called for bladder cancer, parkinsonism, and hypothyroidism to be included as conditions presumed to be a result of service-related exposure to Agent Orange.

This marks a major new pathway for Vietnam vets with LBD. Parkinsonism is a common symptom of LBD and includes muscle rigidity and slowed movements. Previously, only those who had a formal diagnosis of Parkinson's disease could qualify.
